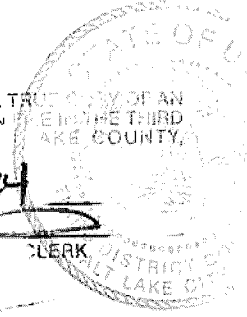

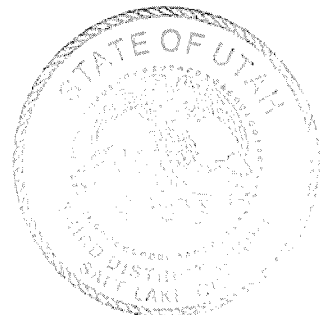

Pursuant to the Court's Order Granting Plaintiff IDG-Sandy, LLC's Motion for Summary Judgment ("Order") entered August 12, 2024, and Rule 58A of the Utah Rules of Civil Procedure, the Court, having found in favor of Plaintiff, hereby enters Final Judgment in favor of Plaintiff and against Defendants Quickfresh, LLC d/b/a Feastbox ("Feastbox") and Jody Rookstool ("Rookstool") in the above-captioned, case.

It is therefore ORDERED, ADJUDGED AND DECREED as follows:

Judgment in the amount of \$165,000.00 is hereby entered against Feastbox and Rookstool plus reasonable attorney's fees beginning the date the Settlement Agreement was signed as established by affidavit and ordered by the Court in accordance with Rule 73 of the Utah Rules of Civil Procedure. Post-judgment interest shall accrue annually at the highest rate allowable by law until this Judgment is satisfied according to Utah Code Section 15-1-4. Plaintiff may be awarded attorneys' fees and costs incurred to enforce this Judgment as established by affidavit and ordered by the Court.

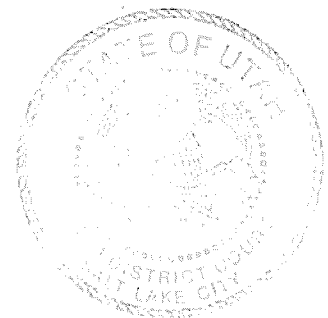
