The UTAH DEPARTMENT OF TRANSPORTATION, by its duly appointed Chief of Right-of-Way Grantor, of Salt Lake City, County of Salt Lake, State of Utah, hereby QUIT CLAIMS to Granger Hunter Improvement District, Grantee, at 3146 West 3500 South, West Valley City, County of Salt Lake, State of Utah zip 84119, for the sum of \*\*\*\*\* Ten and xx/100 \*\*\*\*\* Dollars, and other good and valuable considerations, the following described tract of land in Salt Lake County, State of Utah, to-wit:

A tract of land situated in the E~~N~~W~~N~~ of Section 29, T. 1 S., R. 1 W., S.L.B. & M. The boundaries of said tract of land are described as follows:

Beginning at the Southeast Corner of an entire tract of property, which point is 53.00 feet north from the Southeast Corner of the W~~N~~E~~N~~W~~N~~ of said Section 29; thence N. 89°57'28" W. 61.83 feet along the southerly boundary line of said entire tract; thence N. 44°55'14" W. 28.26 feet along a southwesterly boundary line of said entire tract to the easterly right of way line of West Valley Highway; thence N. 0°07'00" E. 1234.55 feet along said easterly right of way line to a point of tangency with a 2939.789-foot radius curve to the left; thence Northerly 388.69 feet along the arc of said curve and easterly right of way line to the northwesterly boundary line of said entire tract; thence N. 30°03'58" E. 207.865 feet along said northwesterly boundary line to the northeasterly corner of said entire tract; thence South 1822.11 feet along the easterly boundary line of said entire tract to the point of beginning.
