of South Jordan, County of Salt Lake, State of Utah,
hereby CONVEY AND WARRANT to the UTAH DEPARTMENT OF TRANSPORTATION, at
4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum
of Ten and No Cents (and other valuable consideration), Dollars,
and other good and valuable considerations, the following described parcel of land
in Salt Lake County, State of Utah, to-wit:

A parcel of land in fee for an expressway known as Project No. 0154, being
part of an entire tract of property situate in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 20,
T.3S., R.1W., S.L.B. & M.

The boundaries of said parcel of land are described as follows:

Beginning at the Southwest corner of said entire tract, which point is 201.503
meters S. 89°50'00" E. and 108.294 meters N. 0°00'57" E. from the Southwest corner
of said Section 20; thence N. 0°00'57" E. 98.516 meters along the westerly boundary
line to the Northwest corner of said entire tract; thence East 8.409 meters along
the northerly boundary line of said entire tract; thence S. 1°59'59" E. 98.576
meters to the southerly boundary line of said entire tract; thence West 11.873
meters along said southerly boundary line to the point of beginning as shown on the
official map of said project on file in the Office of the Utah Department of
Transportation.

The above described parcel of land contains 998.9 square meters in area.

(Note: To obtain distances in feet, divide above distances by 0.3048. Multiply
above area by 10.764 to obtain square feet.)

To enable the Utah Department of Transportation to construct and maintain a
public highway as an expressway, as contemplated by Title 27, Chapter 12, Section
96, Utah Code Annotated, 1953, as amended, the Owners of said entire tract of
property hereby release and relinquish to said Utah Department of Transportation any
and all rights or easements appurtenant to the remaining property of said Owners by
reason of the location thereof with reference to said highway, including, without
limiting the foregoing, all rights of ingress to or egress from said Owner's
remaining property contiguous to the lands hereby conveyed to or from said highway.
