## **AMENDMENT TO** LOW-INCOME HOUSING CREDIT COMMITMENT AGREEMENT AND DECLARATION OF RESTRICTIVE COVENANTS

This Amendment to Low-Income Housing Credit Commitment Agreement and Declaration of Restrictive Covenants (the "Amended Agreement") is made effective as of the 31st day of December, 1995, by and between Ridgeland, L.C., a Utah limited liability company, its successors and assigns (the "Project Owner"), and Utah Housing Finance Agency ("Agency") an independent state agency and a body politic incorporated in the State of Utah.

## RECITALS

WHEREAS, the Project Owner and the Agency entered into and executed that certain Low-Income Housing Credit Commitment Agreement and Declaration of Restrictive Covenants, dated December 18, 1995 (the "Original Agreement"), which was recorded in the Salt Lake County Real Property Records on December 21, 1995, as Entry No. 6241792, Book 7295, Page 2808, which provided for certain regulatory and restrictive covenants governing the use, occupancy, and transfer of that certain low-income housing tax credit project (the "Project") located upon and being a part of the real property described in Exhibit "A" attached hereto and incorporated herein by this reference; and

WHEREAS, paragraph 13 of the Original Agreement contains a typographical error and the parties desire to amend the Original Agreement to correct the error.

NOW, THEREFORE, in consideration of the mutual premises set forth above, and based upon the mutual covenants and promises hereinafter set forth, and such other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Project Owner and the Agency agree as follows:

- Paragraph 13 of the Original Agreement is hereby amended by substituting the phrase "80 three-bedroom units" as it appears in the second line of paragraph 13, with the phrase "64 three-bedroom units".
- All other terms, conditions and provisions of the Original Agreement shall continue in full force and effect.
- This Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed shall be deemed to be an original, and all of which when taken together shall constitute one and the same agreement.
