FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS ("First Amendment"), is made this 2<sup>nd</sup> day of April 1996, by HAMLET HOMES CORPORATION, a Utah company ("Hamlet") and BALMORAL, L.L.C., a Utah limited liability company ("Balmoral").

LEGAL DESCRIPTION IS BALMORAL TOWNHOUSES, ALL UNITS  
WITNESSETH:

WHEREAS, Hamlet made, executed and caused to be recorded, as Declarant, that certain Declaration of Covenants, Conditions and Restrictions dated March 6, 1996 and recorded among the Salt Lake County Recorder's Office in Book 7350, page 2318 et seq., on March 13, 1996 ("Declaration"), pursuant to which Hamlet subjected all that property described in the Declaration (the "Property") and Declarant formed an association known as, "Balmoral Homeowners Association" ("Association"); and

WHEREAS, pursuant to Section 11.9 of the Declaration, the Declaration may be amended by an instrument in writing, signed and acknowledged by the Declarant and by the President or Vice-President and Secretary or Assistant Secretary of the Association after approval of the amendment at a meeting of the Association duly called for such purpose; and

WHEREAS, Declarant, President and Assistant Secretary have executed this First Amendment subsequent to approval thereof and desire to amend the Declaration as hereinafter set forth.

NOW, THEREFORE, the Declarant hereby declares that the Declaration shall be amended as follows:

1. The name of "Hamlet Homes Corporation" shall be replaced with the name of, "Balmoral, L.L.C." wherever it appears in the Declaration and for all purposes Balmoral, L.L.C. shall be deemed to be the "Declarant" for purposes of the Declaration.
2. In Exhibit B of the Declaration, on line 8, "Phase 4" shall be replaced with "Phase 5".
3. Effect of this First Amendment. The provisions of the Declaration shall for all purposes be, and hereby are, amended in the manner set forth in the provisions of this First Amendment. Except as set forth herein, the provisions of the Declaration shall hereafter remain in full force and effect, as if this First Amendment had not been made.

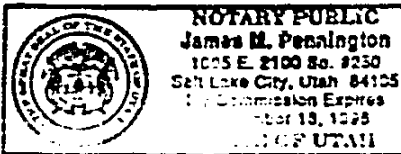



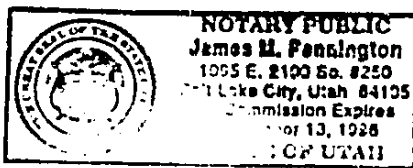
