PART A: PREAMBLE

Do hereby establish the nature of the use and enjoyment of all lots in said subdivision and do declare that all conveyances of said lots shall be made subject to the following conditions, restrictions and stipulations:

PART B: RESIDENTIAL AREA COVENANIS

Land Use and Building Type

No lot shall be used except for residential purposes. No building shall be erected, altered, placed or permitted to remain on any lot other than one detached single-family dwelling not to exceed two stories in heights and private garages for not more than three vehicles. All construction to be of new materials, except that used brick may be used with prior written approval of the City of West Jordan.

2. Dwelling Quality & Size

All building specifications as required by the sub-zone 'G' in the City of West Jordan must be complied with. Exterior materials must include only brick, stone, masonry or stucco. Siding may be used only on soffet and facia.

PART C: GENERAL PROVISIONS

1. Term

These covenants are to run with the land and shall be binding on all parties and all persons claiming under them for a period of forty years from the date these covenants are recorded, after which time, said covenants shall be automatically extended for successive periods of ten years unless an instrument signed by a majority of the ten owners of the lots has been recorded, agreeing to change said covenants in whole or in part.
