hereby GRANT AND CONVEY to the UTAH DEPARTMENT OF TRANSPORTATION, at
4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum
of Ten and No Cents (and other valuable consideration), Dollars,

A perpetual easement, upon part of an entire tract of property, located in the SW
¼ of the NE ¼ of Section 22, Township 2 South, Range 1 West, Salt Lake Base and
Meridian, for the purpose of constructing thereon an irrigation facility and
appurtenant parts thereof to facilitate the widening of a highway known as
Project No. 0068.

Said part of an entire tract is a strip of land 20.00 feet wide adjoining
easterly the following described portion of the easterly right of way line of
said project:

Beginning at the intersection of the North line of said entire tract and the
easterly right of way line of said project, which point is 2376.40 feet
South 0°13'25" West along the Quarter Section Line and 53.00 feet
South 89°55'28" East from the Southwest Corner of the Northeast Quarter of said
Section 22, and running thence South 0°13'25" West 191.86 feet along said easterly
right of way line to the South line of said entire tract, as shown on the official
map of said project on file in the Office of the Utah Department of Transportation.
The above described parcel contains 3848 square feet, or 0.088 acre.

After said irrigation facility and appurtenant parts thereof are constructed on the
above described part of an entire tract at the expense of the Utah Department of
Transportation, said Utah Department of Transportation is thereafter relieved of any
further claim or demand for costs, damages or maintenance charges which may accrue
against said irrigation facility and appurtenant parts thereof.
