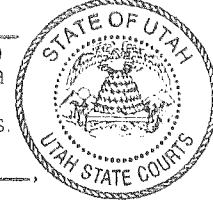

The Court, having entered its Order Granting Motion to Enforce Sanctions and for Summary Judgment on July 29, 2025, hereby enters this Judgment pursuant to Utah R. Civ. P. 58A.

WHEREFORE by virtue of law, and by reason of the premises aforesaid, it is ORDERED, ADJUDGED, and DECREED as follows:

1. Plaintiff Central Bank is hereby awarded Judgment in its favor against Defendant Laurie Brown and awarded damages in the principal sum of \$37,411.19 which is made up of the following:

- a. Compensatory damages in the amount of \$32,726.19;
- b. Attorney's fees in the amount of \$4,237.50 and court costs in the amount of \$447.50 as proven by separate affidavit of counsel; and

c. Interest at the contractual rate of 11% per annum.

**IT IS FURTHER ORDERED THAT THIS JUDGMENT SHALL BE AUGMENTED IN THE AMOUNT OF ADDITIONAL COSTS AND ATTORNEY'S FEES EXPENDED BY PLAINTIFF IN COLLECTING SAID JUDGMENT BY EXECUTION OR OTHERWISE AS ESTABLISHED BY AFFIDAVIT.**



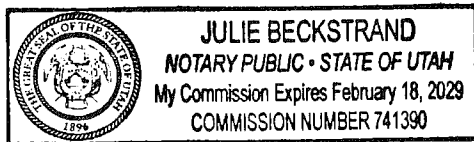
