AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SCENIC MOUNTAIN

This Amendment to the Declaration of Covenants, Conditions and Restrictions for Scenic Mountain recorded on October 24, 2018, as Entry Number 102187, in the Recorder's Office for Utah County (the "Declaration") that established a community known as the Scenic Mountain Homeowners Association (the "Association") is executed on the date set forth below by the Association.

- A. Certain real property in Eagle Mountain City, Utah County, state of Utah, known as the Scenic Mountain Subdivision (the "Project" or "Property") was subjected to certain covenants, conditions, and restrictions pursuant to the Declaration of Covenants, Conditions and Restrictions for Scenic Mountain recorded on October 24, 2018, as Entry Number 102187, in the Recorder's Office for Utah County (the "Declaration");
- B. This Amendment shall be binding against all of the property described in the Declaration; any amendment, annexation or supplement thereto; and as further described in Exhibit A.
- C. This Amendment is intended to remove restrictions on how the Association resolves disputes.
- D. Pursuant to Article 12, Section 12.2 of the Declaration, the undersigned hereby certifies that the affirmative vote of at least sixty-seven percent (67%) of the Members of the Association has been obtained and have approved this Amendment.


NOW THEREFORE, the Association hereby amends the Declaration by replacing the existing language of Article 13 of the Declaration, in its entirety, with the following language:

13.1 Attorney Fees and Costs. In any legal action brought by the Association or its Members to assert the rights of the Association or its Members or to enforce this Declaration, other Association governing documents, the Community Association Act (Utah Code Ann. 57-8a-101 *et seq.*), or the Utah Revised Nonprofit Corporation Act (Utah Code Ann. 16-6a-1601 *et seq.*), the prevailing party shall be entitled to an award of reasonable costs and attorney fees.

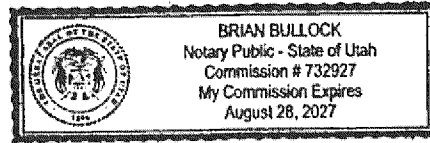
