FIRST AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF THE SUNBROOK SUBDIVISION

(the "First Amendment")

WHEREAS, Capitol City Development Company (herein called "Capitol City") is the Declarant as Identified in the one certain document entitled "Declaration of Covenants, Conditions and Restrictionsof the Sunbrook Subdivision" (herein called the "Declaration") filed for record at Book 7277 pages 0843-0846 in the Office of the Recorder, Salt Lake County, Utah;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that Capitol City does hereby amend the Declaration as follows, to wit:

1. Article I, Section 3 - Easements - is hereby amended to add the following:

3.1 Single Family Residential Universal Easement. (the "Universal Easement") The Owner of each Lot within the Property is hereby declared to have an easement, and the same is hereby granted to Declarant, over all adjoining Lots for the purpose of accommodating any encreachment due to engineering errors, errors in original construction, settlement or shifting of the building, or any other cause. There shall be easements for the maintenance of said encroachment, settling or shifting; provided, however, that in no event shall an easement for encroachment be created in favor of an Owner or Owners if said encroachment occured due to willful misconduct of said Owner or Owners. In the event a structure on any Lot is partially or totally destroyed, and then repaired or rebuilt, the Owners of each Lot agree that minor encroachments over adjoining Lots shall be permitted and there shall be easements for the maintenance of said encroachments so long as they shall exist. In addition, each Lot within the Propertyls hereby declared to have an easement for window wells, sprinkler pipes, overhanging roofs and eaves as originally constructed over each adjoining Lot for the maintenance thereof. Each of the easements hereinabove referred to shall be deemed to be established upon the recordation of this First Amendment and shall be appurtenant to the Lot being serviced and shall pass with each conveyance of sald Lot. Said Universal Easement will continue so long as completed dwellings or dwellings under construction remain on any of the Lots.

2. In all other respects the Declaration is hereby ratified and affirmed as written.
