RIGHT-OF-WAY AND EASEMENT AGREEMENT

PROPERTY RESERVE INC, a Utah nonprofit corporation, as "Grantor" hereby conveys to BRIGHTON AND NORTH POINT IRRIGATION COMPANY, a Utah nonprofit corporation, hereinafter "Grantee", for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, an easement for the construction, installation and maintenance of a waterway and water lines upon, over, under and across the following described land, situated in Salt Lake County, State of Utah, located one foot inside and parallel to all public road frontage on Grantors lands north of 2100 South Street and west of 4800 West Street (Range 2 West only), and also as set forth in Exhibit "A" attached hereto, together with a right of controlled ingress and egress to and along a fifteen-foot strip of adjoining lake shore or canal bank for heavy equipment utilization to maintain Grantee's facilities.

By acceptance or use hereof, Grantee agrees to be bound by and accepts this easement, subject to the following terms and conditions:

- 1. The rights granted hereunder are nonexclusive and the premises indicated herein are subject to being used for utility or other purposes by such person the Grantor may designate at any time, so long as such use does not interfere with Grantees ability to operate and maintain its facilities. Grantor may reasonably relocate this easement as Grantor deems necessary to accommodate Grantor's land utilization, provided Grantee is not damaged thereby.
- 2. Grantee shall not disturb any existing sewer, water, or other utility lines within the boundaries of the easement granted.
- 3. Grantee will comply with all applicable City ordinances, State and County laws, in the installation, maintenance or removal of facilities installed by Grantee.
- 4. Grantee shall maintain facilities in such a manner as will minimize the time and extent of the disturbance to the land and improvements to the fullest extent reasonably possible.
