

Right Of Way Deed

James L Wheelwright and Olive B. Wheelwright grantors...
of Pay County of Weber State of Utah.

hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the
sum of 100⁰⁰ = One hundred ⁰⁰/₁₀₀ DOLLARS.

the following described right of way across the grantor's land in Weber County,

State of Utah, as follows: Right of way for highway known as F.A. Project No. 114-A
across the grantors land in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 13, T. 5 N., R. 2 W., S. L. M.
Said right of way is contained within a parcel of land, the boundaries of which are
described as follows:

Beginning at a point on the south boundary line of said grantors land which
point is 150 ft. south along the west line of said Section 13 and 500.0 ft. east from
the west $\frac{1}{4}$ corner of said Section 13; thence east along said south boundary line
86.1 ft. to the center line of survey of said project at Engineer's Station 16+07.1;
thence continuing east 81.6 ft.; thence N.51°59'E., 28.4 ft. parallel to and 50 ft.
distant southeasterly from said center line of survey; thence N.46°16'E., 100.5 ft. to
a point 40 ft. perpendicularly distant, southeasterly from engineer's station 18+00;
thence N.38°01'W., 80 ft.; thence S.57°42'W., 100.5 ft. to a point 50 ft. perpend-
iculary distant northwesterly from said center line of survey at Engineer's Station
17+00; thence S.52°54'W., 160.9 ft. to the point of beginning as shown on the official
map of said project on file in the office of the State Road Commission of Utah. Above
described parcel of land contains 0.43 acre, of which 0.35 acre is now occupied by
the existing highway. Balance 0.08 acre.

In executing this deed, the grantor hereby grants to the State Road Commis-
sion of Utah permission to relocate and reconstruct within the grantors land and
outside the limits of above described right of way, all irrigation ditches existing
within said limits of above described right of way.

The purpose of this deed is to grant a perpetual right of way for highway purposes.

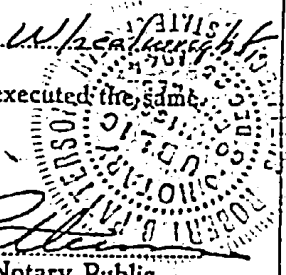
