tinued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone
circuits of the Grantee, and no guy anchors and 8 poles, with the necessary guys, stubs, cross-arms and other
attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon
and across the premises of the Grantor, in Salt Lake County, Utah, along a line described as follows:

Beginning on west boundary line of grantor's land at a point 875 ft. south, more or less, from the northwest
corner of Sec. 25, T. 4 S., R. 1 W., S. L. B.M., thence running S. 23° 23' E. 1210 ft., more or less, to fence
on south boundary line of said land and being in the W 1/2 of the NW 1/4 said Sec. 25.

Together with all rights of ingress and egress necessary or convenient for the full and complete use,
occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, includ-
ing the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure
or interfere with the Grantee's use, occupation or enjoyment of this easement.

One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and tele-
phone circuits of the Grantee, and 7 guy anchors and 18 poles, with the necessary guys, stubs, cross-arms and tele-
phone circuits of the Grantee, and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained
upon and across the premises of the Grantor, in Salt Lake County, Utah, along a line described as follows:

Beginning on north boundary line of grantor's land at a point 1156 ft. east, more or less, from the west
quarter corner of Sec. 25, T. 4 S., R. 1 W., S. L. B.M., thence running S. 33° 23' E. 1435 ft., more or less,
