SPECIAL WARRANTY DEED

CHRIST OF LATTER-DAY SAINTS, a Utah corporation sole, GRANTOR, of Salt Lake City, County of Salt Lake, State of Utah, hereby conveys and warrants against all claiming by, through or under it, and against acts of itself, to **ROCKY MOUNTAIN FABRICATION**, GRANTEE, of 1125 West 2400 North, Salt Lake City, County of Salt Lake, State of Utah, for the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, the following parcel of land, situate in the County of Salt Lake, State of Utah, and more particularly described as follows:

Beginning on a point which is North 0°34'30" East 487.77 feet and South 89°52'30" East 1424.26 feet from the Southwest corner of Section 14, Township 1 North, Range 1 West, Salt Lake Base and Meridian; thence North 0°31'30" East 874.71 feet; thence South 89°52'30" East 257.26 feet; thence South 0°31'37" West 650.19 feet; thence South 45°18'33" West 365.21 feet; thence North 0°34'30" East 32.90 feet to the point of beginning.




Subject to easements, rights, rights-of-way, reservations, conditions, restrictions, covenants and taxes and assessments of record or enforceable in law or equity.


