Pursuant to Petition No. 400-96-30)

AN ORDINANCE APPROVING THE VACATION OF A PORTION OF
KINNEY & GOURLAY'S SUBDIVISION, AS REQUIRED BY SECTION 10-9-
808, UTAH CODE ANNOTATED, PURSUANT TO PETITION NO. 400-96-
30.

WHEREAS, Petition No. 400-96-20 was filed with the
City, requesting the City to allow the vacation of blocks
65 and 66 of the Kinney & Gourlay's Subdivision; and

WHEREAS, one hundred percent of the owners of the
property within and adjacent to the subdivision have not
consented to the vacation; and

WHEREAS, the City Council has held a public hearing
after giving the required notices and has reviewed the
vacation which has been previously preliminarily approved by
the Planning Commission on April 23, 1996; and

WHEREAS, good cause exists for the vacation of the plat
and the City Council finds neither the public nor any person
will be materially injured by the proposed vacation;


