The following changes are made to the Declaration pursuant to the terms of Paragraph 14 of said Declaration:

Paragraph 4.9 is changed to read as follows:

An Owner shall not, by deed, plat or otherwise, subdivide or in any manner cause his or her Lot to be separated into physical tracts or parcels smaller than the whole Lot as shown on the Map, nor shall any Owner cause, suffer or permit the fee Ownership of his Lot or Dwelling to be separated or divided into annually recurring time share units or time share units of any other duration, form or kind whatsoever, unless and until said Owner shall obtain the affirmative vote and consent of at least three-fourths (3/4) of the Owners of record of the Lots of this subdivision. In voting, each Lot Owner of record shall be entitled to cast one vote for each Lot owned by him or her. Provided, however, where there is more than one record Owner of a Lot, all such Owners must act unanimously to cast a vote for that Lot. Any further subdivision pursuant to this Paragraph shall be accomplished by recordation of an instrument executed by such Lot Owners.

THIS AMENDMENT MAY BE EXECUTED IN COUNTERPARTS AND SHALL TAKE EFFECT WHEN RECORDED.
