grants and conveys unto the TAYLORSVILLE-BENNION IMPROVEMENT
DISTRICT, a body politic, an easement to construct, reconstruct,
operate, repair, replace and maintain a water line and appurtenant
structures on, over, across and through the following land
described parcel:

BEGINNING at a point which is North 89°58'51" East 543.34
feet along quarter section line and North 0°01'25" West
65.50 feet from the center of Section 22, Township 2
South, Range 1 West, Salt Lake Base and Meridian and
running thence North 0°01'25" West 154.24 feet; thence
North 64°41'40" East 83.25 feet; thence North 35°34'58"
West 12.70 feet to the Southeast corner of Redwood No.2
P.U.D.; thence South 89°49'42" West 92.89 feet; thence
South 0°01'25" East 199.88 feet; thence North 89°58'51"
East 25.00 feet to the point of BEGINNING.

The GRANTOR SHALL NOT build thereon any permanent structure or
building, nor plant large trees whose root zones would contact or
interfere with the pipeline. The easement may, however, be crossed
or covered with sidewalks, curb and gutter, roadways, driveways,
fences or similar improvements.
