Right Of Way Deed

Jesse Bonwhuis, wife Marie and Christian Bonwhuis and Mary E. Bonwhuis grantor^s
 of Key County of Weber State of Utah,
 hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for
 the sum of Three Hundred Eighteen DOLLARS,
 the following described strip or parcel of land, as a perpetual right of way for highway purposes
 across the grantor^s land in Weber County, State of Utah, as follows:

Right of way for highway known as F. A. Project No. 214-C across the grantors land in Lots 9 and 10, Local Survey of the SW¹/₄ SW¹/₄ of Section 36, T. 6 N., R. 2 W., S. L. M. Said right of way is contained within a parcel of land bounded on the west side by the west boundary line of said Section 36 and bounded on the easterly side, from the south boundary line of said Section 36 to Engineer's Station 34+50, by a line parallel to and 80 ft. distant easterly from the center line of survey of said project; thence by a straight line running to a point 60 ft. east from said center line at the north boundary line of said grantors land. Said center line is described as follows:

Beginning at the intersection of said south boundary line of Section 36 and said center line of survey at Engineer's Station 31+44.4, which point is 0.8 ft. east from the southwest corner of said Section 36; thence N. 0°04' E., 1315.6 ft. to the intersection of said center line of survey at Engineer's Station 44+60 and the said north boundary line produced of said grantors land, which point is 1315.6 ft. north along said west section line and 5.4 ft. west from said southwest corner of Section 36, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described parcel of land contains 2.11 acres, of which 1.05 acres are now occupied by the existing highway and railroad rights of way. Balance 1.06 acres.

In executing this deed, the grantors hereby grant to the State Road Commission of Utah permission to relocate and reconstruct within the grantors land and outside the limits of above described right of way, all irrigation ditches existing within said limits of above described right of way.
