MEMORANDUM OF LEASE BETWEEN

BEGINNING AT A POINT SOUTH 742.72 FEET AND WEST 158.76 FEET AND S89°30'15" W 213.50 FEET ALONG THE MONUMENT LINE OF MURRAY-HOLLADAY ROAD AND NORTH 533.01 FEET AND EAST 6.75 FEET FROM THE NORTH QUARTER CORNER OF SECTION 8, TOWNSHIP 2 SOUTH, RANGE 1 EAST, SALT LAKE BASE AND MERIDIAN; AND RUNNING THENCE EAST 30.00 FEET; THENCE SOUTH 30.00 FEET; THENCE WEST 30.00 FEET; THENCE NORTH 30.00 FEET TO THE POINT OF BEGINNING.

CONTAINING 0.021 ACRE

The date of execution of the Lease was September 7, 1995. Subject Lease is for a term of five (5) years and shall commence on January 1, 1996, (the "Commencement Date") and terminating at midnight on the last day of the month in which the 5th annual anniversary of the Commencement Date shall have occurred. 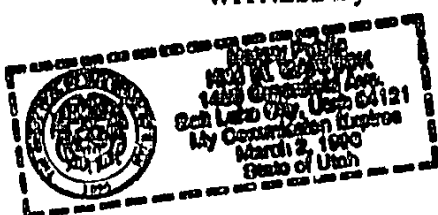
