and to the heirs, successors and assigns of each assignee named above, that percentage of overriding royalty as shown above under the oil and gas leases as set forth on Exhibit "A" attached hereto and made a part hereof.

If the working interest owned by ASSIGNOR under a lease on Exhibit "A" is less than the total working interest, or if a lease thereon covers less than the full mineral ownership of the leased substances, then and in each case the amount of overriding royalty hereby assigned under such lease shall be reduced proportionately to reflect the overriding royalty herein assigned as a percentage of the total working interest owned by assignor in the full mineral ownership of such oil and gas.

The interests hereby conveyed are free of all cost and expense except production taxes levied and assessed upon the overriding royalty share of production hereby assigned. All amounts payable on this overriding royalty interest shall be paid monthly at the same time and on the same valuation basis as payments are made to the lessor for lessor's royalty reserved in the lease. If an assignee does not elect to take in kind his proportionate share of the oil or gas affected by this assignment, then the assignor or any other operator of said lease shall sell such royalty oil and/or gas at a price not less than the best available competitive price for same and cause the purchaser thereof to make direct payments to the assignee herein named.

This overriding royalty and all other terms and conditions of this assignment shall apply to any and all extension, renewal and substitute leases obtained by Assignor, his successor or assigns on the lands described herein on Exhibit "A".


