CORRECTED EASEMENT

(NOTICE: This is a Corrected Easement, replacing and superseding that Easement dated February 28, 1997, recorded at Book 7618 Page 0808, Entry No. 6593157 of the records of the Salt Lake County Recorder, State of Utah.)

Draper Irrigation Company hereby grants to the Utah State Board of Water Resources, an easement, as described below, for the purpose of inspecting, maintaining, repairing, and otherwise securing access to the pressure irrigation pipeline and associated pressure irrigation pipeline equipment located within the easement. Said easement is a strip of land, 10 feet each side of the following described line as follows:

A perpetual easement, situate in the SE^{1/4} of Section 29, T.3S., R.1E., SLB&M, in Salt Lake County, Utah.

Beginning at a point 1268.937 feet N. 0°31'14" E. along the Section line and 174.74 feet west from the Southeast corner of said Section 29; thence N. 42°22'48" W. 78.34; thence N. 47°50'29" W. 247.63 feet to the point of tangency of a 255.00 foot radius curve to the left; thence Northwesterly 170.51 feet along the arc of said curve; thence N. 86°09'15" W. 867.22; thence N. 89°54'56" W. 632.12 to the point of tangency of a 110.00-foot radius curve to the left; thence Westerly 76.06 feet along the arc of said curve; thence N. 50°17'46" W. 107.95 feet to a point 1700.45 feet N. 0°20'32" E. and 427.96 feet east from the South Quarter corner of said Section 29.


