UTAH POWER & LIGHT COMPANY
POLE LINE EASEMENT

13. James J. Ure and Eleanor Ure his wife, Grantors of Summit County, Utah, hereby convey and warrant to Utah Power & Light Company, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and 1 guy anchor 7 poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across ~~the~~ premises of the Grantor in Summit County, Utah, along a line described as follows:

Beginning on East boundary line of Grantor's land at a point 51.5 feet North and 1588 feet West, more or less, from the Southeast corner of Section 18, T. 2 S., R. 6 E., S.L.B & M. thence running S. 89°44' W. 1040 feet, more or less, thence S.45°44' W. 2 feet to fence on West boundary line of said land. Also beginning at fence on South line of State Highway (Route No. 34) and North boundary line of Grantor's land at a point 1430 feet South and 830 feet East, more or less, from the Northwest corner of Section 19, said Township and Range, thence running S. 66°24' W. 1205 feet on said land and being in SW $\frac{1}{4}$ of SE $\frac{1}{4}$, said Section 18, in Lot 2, said Section 19, and in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 24, T. 2 S., R. 5 E., S.L.B.&M.,

Together with all rights of ingress and egress necessary or convenient for the full complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhangings branches and other obstructions which may injure or interfere with the Grantee's use, occupation, or enjoyment of this easement.
