the State of Utah, Grantor, hereby QUIT CLAIMS to the UTAH DEPARTMENT OF TRANSPORTATION, Grantee, for the sum of SEVENTEEN AND NO/100 (\$17.00) Dollars, the following described

Parcel of land in Muhur County, State of Utah, to-wit:

A parcel of land situated in the ~~NE 1/4~~ of Block 23, Lamdale Addition, in Section 6, T. 5 N., R. 1 W., S.D.M. The boundaries of said parcel of land are described as follows:

Beginning on the center line of vacated Aspen Avenue, Lamdale Addition at a point 270.0 ft. perpendicularly distant northwesterly from the center line of a freeway known as Project No. 15-8, which point is approximately 1027 ft. east and 552 ft. south from the NE corner of the ~~NE 1/4~~ of said Section 6; thence West 5 ft., more or less, to the southeasterly right of way line of the Hill Field Branch of the U.P.R.R.; thence Northwesterly 213 ft., more or less, along said southeasterly right of way line to the center line of vacated Colorado Avenue; thence South 37 ft., more or less, along said center line to a point 270.0 ft. perpendicularly distant northwesterly from the center line of said Project; thence S. 64°39' W. 180 ft., more or less, to the point of beginning. The above described parcel of land contains 0.06 acre, more or less.

Any and all water rights pertaining to the above described land are hereby reserved by the grantor, and the grantees shall not be liable for any water assessments now due or which shall become due.

"Excepting therefrom any portion thereof lying northerly of a straight line parallel with and 105 feet distant southeasterly, measured at right angles, from the center line of the main track of the Hill Field Branch of the Union Pacific Railroad Company, as constructed and operated."
