## WARRANTY DEED.

Vienna C. Edwards Henline, formerly known as Vienna Edwards, and Vienna C. Edwards, grantor, of Salt Lake City, Salt Lake County, State of Utah, hereby conveys and warrants to Douglas C. Edwards and Floyd Edwards, grantees, of Charleston, Wasatch County, State of Utah, for the sum of Ten Dollars (\$10.00) and other good and valuable considerations, the receipt of which is hereby acknowledged, the following described tracts of land, situated in Wasatch County, State of Utah, to-wit:

Beginning at the Southeast corner of the Northwest quarter of Section 14, in Township 4 South of Range 4 East of the Salt Lake Meridian; and running thence North 40 rods; thence West 80 rods; thence South 40 rods; thence East 80 rods to the place of beginning, containing 20 acres.

ALSO: Lots 2 and 3 in Block 6 in the Charleston Survey of Building Lots, situated in the West half of the Southwest quarter of Section 14, in Township 4 South of Range 4 East of the Salt Lake Meridian; EXCEPT the following part thereof, to-wit: Beginning at the Southwest corner of Lot 2, in said Block 6, and running thence North 3.50 rods; thence East 26 rods; thence South 3.50 rods; thence West 26 rods to the place of beginning.

ALSO THE TRACT: Beginning at the Southwest corner of Section 2, in Township 4 South of Range 4 East of the Salt Lake Meridian; and running thence South 22 chains; thence South 89°12' East 9 chains; thence North 6° West 6.53 chains; thence North 17°20' West 4 chains; thence North 85°40' East 7 chains; thence North 2°45' East 3.30 chains; thence North 58°50' West 2.85 chains; thence North 14°55' West 3.50 chains; thence North 27°30' East 2.91 chains; thence North 10° East 7.93 chains; thence North 6°40' West 2.62 chains; thence North 78°45' West 9.20 chains; thence West 4.75 chains, more or less, to the West line of said Section 2; thence South 11.17 chains, more or less, to the place of beginning.
