Sup. 315f).

Therefore, pursuant to the Delegation of Authority contained in the Bureau of Land Management Manual 1203 dated April 6, 1998, this list embracing 19.18 acres is hereby approved subject to valid existing rights at the date of selection.

EXCEPTING AND RESERVING TO THE UNITED STATES from the land so clear listed:

1. A right-of-way thereon for ditches and canals constructed by the authority of the United States. Act of August 30, 1890 (43 U.S.C. 945).

SUBJECT TO:

1. Those rights for a power transmission line granted to Pacificorp dba UP&L, its successors or assigns, by right-of way UTU-43523, pursuant to the Act of October 21, 1976 (90 Stat. 2776; 43 U.S.C 1761).
