SNOW, grantee, of Salt Lake City, County of Salt Lake, State of Utah, for the sum of Ten and no/100 (\$10.00) Dollars and love and affection, the following described tract of land in Salt Lake City, Salt Lake County, State of Utah;

Commencing at a point on the east line of State Street, which point is 35 feet east and 175 feet south from the center line of a stone street monument at the intersection of State Street with First North Street in Salt Lake City, Salt Lake County, Utah, and from said point of commencement running south 90 feet; thence east 109.81 feet, more or less, to the west line of a right of way; thence north 96.4 feet along the west line of said right of way to a point which is north 86° 45' 13" east 110 feet from the place of beginning; thence south 86° 40' 13" west 110 feet to place of beginning, together with the appurtenances thereunto belonging.
