FINAL JUDGMENT AGAINST DEFENDANTS ON ALL CLAIMS

THIS CASE came before the Court for a jury trial on January 28, 2019, on the Amended
Complaint by Plaintiff, RANDALL DIEZ, D.M.D., against Defendants, MBGS, LLC d/b/a Doctor
Alliance Group d/b/a MBGSOPTIONS d/b/a The Perfect Bite Doctor d/b/a Dental Revenue Systems
f/k/a Truman Marketing, LLC and MIKE SMITH.

It is ORDERED AND ADJUDGED as follows:

1. A Final Judgment is granted in favor of Plaintiff, Randall Diez (5010 Gunn
Highway, Tampa, Florida 33624), and against the Defendants, MBGS, LLC, a Utah limited
liability corporation d/b/a Doctor Alliance Group d/b/a The Perfect Bite Doctor d/b/a Dental
Revenue Systems f/k/a Truman Marketing, LLC (3214 N. University Avenue, Suite 254, Provo,
Utah 84604), and Mike Smith (3214 N. University Avenue, Suite 254, Provo, Utah 84604).

2. Plaintiff shall recover from the Defendants, jointly and severally, the amount of \$403,320.64, that shall bear interest at the applicable statutory rate of 6.33%, for which let execution issue.

3. Plaintiff, Randall Diez, is entitled to recover costs from the Defendants, MBGS, LLC and Mike Smith.

4. Defendants shall complete under oath the Fla. R. Civ. P. Form 1.977 (Fact Information Sheet) attached to Plaintiff's conformed copy of the Final Judgment, including all required attachments, and serve it on the Plaintiff's attorney at the address referenced below, no later than 45 days after the date of this final judgment, unless the judgment is satisfied or post-judgment discovery is stayed.

5. The Court reserves jurisdiction to determine the amount of costs to be awarded to the Plaintiff, and to determine whether Plaintiff is entitled to recover attorneys' fees and expenses and, if such entitlement is determined, the amounts to be awarded, and to enter any other or additional orders that may be necessary or appropriate.


