- the The research (s) herein granted are subject to all easements and encumberates of research and are non-exclusive provided later granted encountry shall be subject to Grantee's rights and uses.
- (b) All times, equipment and their related components and supports placed within the decembed eccement area(s) by Grantee, or Grantee's agents or contractors, pursuant to this instrument ("Grantee's Property") shall remain the property of Grantee.
- (c) Granton and its successors and assigns retain the right to full use of the surface of the described easement area(s) except where Grantee has placed Grantee's Property, provided, however, Granton will not erect any building or major structure within the described easement area(s). All lines shall be below the surface of the described easement area(s), except such other communication facilities that are required upon the surface of the casement.
