NOTICE OF ADOPTION OF REDEVELOPMENT PLAN ENTITLED "WOODS CROSS NEIGHBORHOOD DEVELOPMENT PLAN" AND DATED SEPTEMBER 15, 1982

Pursuant to Section 11-19-32.1, Utah Code Annotated, 1953, as amended, the following information is recorded in the Office of the Recorder of Davis County:

(1) A Description of the Land Within the Project Area.

Beginning at a point on the West boundary line of Bountiful City and the East boundary line of Woods Cross City which is North 89° 59' 16" West 132.00 feet along the Section line and South 0° 11' 26" East 539.88 feet along the centerline of 500 West Street, and South 0° 00' 04" East 605.27 feet along the centerline of said 500 West Street and West 462.00 feet from the Northeast Corner of Section 25, Township 2 North, Range 1 West, Salt Lake Base and Meridian; and running thence West 268.68 feet; thence South 1° 54' 34" East 75.36 feet along a fence line; thence North 89° 12' 30" West 330.77 feet along a fence line; thence North 10° 02' East 449.41 feet along the Easterly no access line of I-15 Freeway; thence North 88° 53' East 518.65 feet along the centerline of Mill Creek and said common city boundary line; thence South 0° 00' 12" East 381.90 feet along said common city boundary line to the point of Beginning.

(2) A Statement that the Redevelopment Plan for the Project Area has been Approved. The City Council of Woods Cross City has adopted a redevelopment plan entitled "Woods Cross Neighborhood Development Plan" dated September 18, 1982 by Ordinance No. 238 dated October 12, 1982.

(3) The Date of Approval. The Redevelopment Plan was approved on the 12th day of October at the time the
