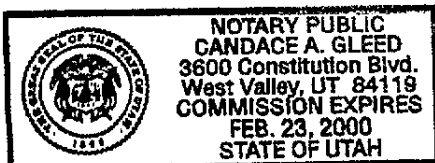

An Ordinance Enforcement Officer conducted an inspection of the property identified above, on March 16, 1998. In accordance with the West Valley Municipal Code, the following violation(s) observed on your property include:

1. Accumulation of Solid Waste 24-2-111 25.00 daily fine  
discarded piece of carpet on the driveway, litter through out the yard.
2. Inoperable and or Unlicensed Vehicle 24-2-111-A 25.00 daily fine  
unlicensed red truck on the driveway.

In order to bring your property into compliance with the law, you are required to meet the conditions stated below and obtain an inspection and a Notice of Compliance from an Ordinance Enforcement Officer. A Notice of Compliance must be obtained by April 09, 1998.

1. All litter, trash, debris, carpet must be cleaned up and removed from the property.
2. All vehicles that are inoperable and or unlicensed will have to be removed from the property or put into and enclosed structure such as a garage.

Failure to comply by April 09, 1998 shall result in a daily fine of 50.00 beginning on April 10, 1998. The fines will be owed every day until an officer inspects the property and finds it in compliance. **It is your responsibility** to contact our office and schedule a compliance

inspection. No additional notice will be sent to you. If you fail to have the property inspected and obtain a Notice of Compliance, you will be billed on a monthly basis for fines and fees owed to the city. Without additional notice to you, the city may also obtain an order to enter your property and remove the violations at your expense.

Please be advised that the city will conduct one compliance inspection at no charge to you. If the property is not in compliance at that time and additional inspections are necessary, a \$50 reinspection fee will be charged for each additional inspection. This amount will be added to your monthly bill.
