WARRANTY DEED

GEORGE C. CRITTENDEN and LUELLA CRITTENDEN, His wife, Grantors of Ogden City, County of Weber, State of Utah, hereby convey and warrant to Ray Rees and Mima Rees, husband and wife, as joint tenants of the entirety with full right of survivorship, Grantees of Ogden City, County of Weber, State of Utah, for the sum of Ten Dollars, the following described tract of land in Summit County, State of Utah,

A tract of land situated in Section 21, Township 2 North, Range 5 East, Salt Lake Base and Meridian, and beginning 22 rods South from the Northwest corner of said Section, and running 112 rods and 4 feet North 86° East; thence South 40 rods; thence South 86° West 112 rods and 4 feet; thence North 40 rods to beginning, containing 28 acres, more or less.
