**DECLARATION OF PARTIAL REMOVAL
OF THE FIELDS AT DRAPER PHASE 2C CONDOMINIUMS
FROM THE PROVISIONS OF
THE UTAH CONDOMINIUM OWNERSHIP ACT**

THIS DECLARATION OF PARTIAL REMOVAL ("Declaration") is made as of this 22 day of September, 1998, by HOLMES & ASSOCIATES, L.C., a Utah limited liability company ("Declarant").

RECITALS

A. **Original Declaration and Plat.** On May 1, 1998, Declarant filed a Declaration of Covenants, Conditions and Restrictions of The Fields at Draper Phase 2C Condominiums, as Entry Number 6949319, in Book 7965, beginning at page 229 in the official records of Salt Lake County, Utah (the "Original Declaration"), together with the Record of Survey Map (the "Plat"). The Original Declaration created a residential condominium project consisting of 192 units, subject to the Utah Condominium Ownership Act, Utah Code Ann. § 57-8-1 et seq. (the "Act"). The real property subject to the Original Declaration is located in the City of Draper, Salt Lake County, Utah (the "Original Property").

B. **Ownership.** At all times from the filing of the Original Declaration and the Plat through and including the date of this document, Declarant has been the owner in fee of all condominium units, together with a 100% ownership interest in the common areas appurtenant to such units.

C. **Intention of Declarant.** Declarant desires to amend and restate the Original Declaration in its entirety to change the name of the condominium project to "The Fields at Draper Condominiums" and to permit the development of the project as an expandable condominium project. Declarant intends to accomplish such objective by recording an Amended and Restated Declaration of Condominium of The Fields at Draper Condominiums ("Amended Declaration"), together with an amended Plat. The expandable condominium project shall consist of that portion of the Original Property currently under development, Unit Nos. 1001 through 1034 (the "Project Property"). The remainder of the Original Property, less dedicated public streets created within the Original Property, shall be removed from the condominium project and designated in the Amended Declaration as additional land, which additional land may be used to expand the project with up to 158 additional units (the "Additional Land").

D. **Description of Property.** The Original Property, the Project Property and the Additional Land are more particularly described on Exhibits "A," "B" and "C," respectively. Such exhibits are attached to and incorporated in this Declaration by reference.

NOW THEREFORE, in pursuance of the foregoing, the Declarant declares and certifies as follows:

1. Incorporation by Reference. The recitals to this Declaration are an integral part of this Declaration, and are incorporated by reference in this Declaration.

2. Partial Removal of the Original Property. That portion of the Original Property, consisting of Units 1035 through 1192 as shown on the Plat, together with the common areas surrounding such Units, less the dedicated public streets created within the Original Property previously submitted to the provisions of the Act, are hereby removed from the provisions of the Act pursuant to Section 57-8-22 of the Act. Such removed property shall become the Additional Land created under the terms of the Amended Declaration to be recorded concurrently with the recordation of this Declaration in the office of the Salt Lake County Recorder.

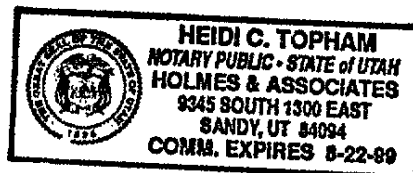

SOUTH PARCEL

Beginning at a point which is on the South side of the right-of-way of South Fork Drive said point also being North 89°51'21" West 938.22 feet and South 191.70 feet from the North quarter corner of Section 7, Township 4 South, Range 1 East, Salt Lake Base and Meridian, and running thence Southeasterly along the arc of a 18.00 foot radius curve to the right through a central angle of 90°00'00" (center bears South 31°55'10" West) a distance of 28.27 feet to a point on the west right-of-way line of Honeyfield Drive; thence South 31°55'10" West 50.61 feet along said West right-of-way line to a point of curvature; thence Southeasterly along the arc of a 250.00 foot radius curve to the left through a central angle of 63°08'39" a distance of 253.48 feet to a point of tangency; thence South 31°13'29" East 213.76 feet along said West right-of-way line to a point of curvature; thence Southerly along the arc of a 18.00 foot radius curve to the right through a central angle of 106°40'42" a distance of 33.51 feet to a point on the North right-of-way line of Mayfield Drive;
