## FIRST AMENDMENT TO THE PROTECTIVE COVENANTS APPLICABLE TO MOUNTAIN VIEW ESTATES #5, #6 AND #7

The undersigned, representing a majority of the owners of lots within Mountain View Estates #5, #6 and #7, situated in West Jordan, Salt Lake County, Utah, which lots are subject to Protective Covenants, dated March 1, 1971, and recorded on April 6, 1971, in Book 2948 at Pages 151 to 155 of the official records of Salt Lake County, Utah, hereby amend said Protective Covenants, effective October 17, 1998 (the date an informal petition was circulated among the lot owners), as follows.

All provisions for, and references to, bridle paths in the subject subdivisions shall be deleted, and no part of any lot shall be subject to an easement for bridle paths. Accordingly, Paragraph B-6 of the Protective Covenants is hereby amended and restated in its entirety to read as follows:

"B-6. EASEMENTS. Easements for installation and maintenance of utilities, including irrigation systems, and drainage facilities, are reserved as shown on the recorded plat and over the rear five (5) feet of each lot. Within these easements, no structure, planting or other material shall be placed or permitted to remain which may damage or interfere with the installation and maintenance of utilities, or which may change the direction of flow of drainage channels in the easements, or which may obstruct or retard the flow of water through drainage channels in the easements. The easement area of each lot and all improvements in it shall be maintained continuously by the owner of the lot, except for those improvements for which a public authority or utility company is responsible."

Paragraph B-7(c) of the Protective Covenants is hereby amended and restated in its entirety to read as follows:

"Each Lot is to be developed and maintained by its owner in an attractive, safe and sanitary manner."

Paragraph B-13 of the Protective Covenants is hereby amended and restated in its entirety to read as follows:

"No fence, wall, hedge or shrub planting which obstructs sight lines at elevations between two (2) and six (6) feet above the roadways shall be placed or permitted to remain on any corner lot within the triangular area formed by the street lines, or in the case of a rounded property corner from the intersection of the street property lines extended. The same sight-line limitations shall apply on any lot within ten (10) feet from the intersection of a street property line with the edge of a driveway. No tree shall be permitted to remain within such distances of such intersections unless the foliage line is maintained at sufficient height to prevent obstruction of such sight lines."
