NOTICE OF ADOPTION OF ECONOMIC DEVELOPMENT PLAN ENTITLED  
"13400 SOUTH BANGERTEER HIGHWAY ECONOMIC DEVELOPMENT PLAN"  
AND DATED OCTOBER 15, 1998

Pursuant to Section 17A-2-1257, Utah Code

Annotated, 1953, as amended, the following information is  
recorded in the Office of the Recorder of Salt Lake  
County:

(1) A Description of the Land Within the Project Area.

All that real property in Section 32, Township 3  
South, Range 1 West, Salt Lake Base and Meridian, Salt  
Lake County, Utah, described as follows:

said curve to the left an arc length of 131.73 feet, more  
or less; thence South 44°58'52" East a distance of 1103.29  
feet, more or less; thence South 40°45'49" West a distance  
of 33.64 feet, more or less, to a beginning of a curve,  
concave to the East, having a radius of 190.00 feet, more  
or less, and a central angle of 84°30'53"; thence along  
said curve to the left an arc length of 280.26 feet, more  
or less; thence South 43°45'03" East a distance of 328.64  
feet, more or less, to a beginning of a curve, concave to  
the West, having a radius of 120.00 feet, more or less and  
a central angle of 43°53'40"; thence along said curve to

the left an arc length of 91.93 feet, more or less; thence South 00°08'37" West a distance of 38.89 feet, more or less; thence South 89°51'23" East a distance of 80.00 feet, more or less; thence North 00°08'37" East a distance of 103.00 feet, more or less; thence South 89°51'23" East a distance of 30.00 feet, more or less; thence North 00°08'37" East a distance of 30.00 feet, more or less; thence South 89°51'23" East a distance of 113.95 feet, more or less; thence North 48°08'58" East a distance of 591.31 feet, more or less to the Point of Beginning. Contains 2,036,510 square feet or 46.75 acres.

The Basis of Bearings for this description is the centerline of 3600 West Street, namely North 00°12'13" East, as shown on Area Reference Plat for Section 32, Township 3 South, Range 1 West, Salt Lake Base and Meridian, on file in the office of the Salt Lake County Surveyor.

(2) A Statement that the Economic Development Plan for the Project Area has been Approved. The City Council of Riverton City has adopted an Economic Development Plan entitled "13400 South Bangerter Highway Economic Development Plan" dated October 15, 1998 by Ordinance No. 12-15-98-1 dated December 15, 1998.

(3) The Date of Approval. The Economic Development Plan was approved on the 15th day of December, 1998 at the time the Ordinance was adopted and became effective on the 22nd day of December, 1998 on the date that the Ordinance was first published.


