## AMENDMENT TO THE DECLARATION OF ANNEXATION PETROGLYPHS OF CORAL CANYON PHASE 1

THIS AMENDMENT TO THE DECLARATION OF ANNEXATION is made this day of This 2001, by SUNCOR DEVELOPMENT COMPANY, an Arizona corporation and the STATE OF UTAH, acting through the SCHOOL AND INSTITUTIONAL TRUST LANDS ADMINISTRATION ("Declarant"), with reference to the following:

## WITNESSETH

WHEREAS, Declarant executed and caused to be recorded that certain Residential Declaration of Covenants, Conditions and Restrictions for Coral Canyon dated Mach 1, 2000 and recorded on March 21, 2000 as Instrument No. 00679603, in Book 1363, Page 1079, et seq. in the records of the Washington County Recorder, Utah (the "Declaration"); and

WHEREAS, pursuant to the terms of such Declaration, Declarant executed and caused to be recorded that certain Declaration of Annexation Petroglyphs of Coral Canyon dated February 20, 2001 and recorded on February 22, 2001 as Instrument No. 00711819, in Book 1396, Page 1623, et seq. in the records of the Washington County Recorder, Utah (the "Petroglyphs Declaration"); and

WHEREAS, the Pertoglyphs Declaration is a Tract Declaration, as defined in the Declaration; and

WHEREAS, pursuant to Section 3 of the Petroglyphs Declaration, the Petroglyphs Declaration may only be amended as provided in Article 11, Sections 11.2 of the Declaration, and

WHEREAS, pursuant to Section 11.2 of the Declaration, at any time, Declarant shall have the right to amend any Tract Declaration to correct any error or inconsistency if the amendment does not adversely affect the rights of any Owner (as defined in the Declaration); and

WHEREAS, the Petroglyphs Declaration was recorded without listing any land use classifications, as required in the Declaration; and

WHEREAS, Declarant desires amend the Petroglyphs Declaration to add land use

classifications to make it consistent with the terms of Section 3.2 of the Declaration; and


WHEREAS, such amendment does not adversely affect the rights of any Owner.
