ACCESS EASEMENT

WHITE**, of 5490 North Canyon Road, Provo, UT 84604, **DEAN B. HALL AND DONNA R. HALL**, of 5480 North Canyon Road, Provo, UT 84604, and **SCOTT G. AND ELLEN V. SMITH**, of 5440 North Canyon Road, Provo, UT 84604, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right-of-way for access across property owned by the Grantors in Utah County, Utah, along the area described as follows:

A PORTION OF THE SOUTHWEST QUARTER OF SECTION 7, TOWNSHIP 6 SOUTH, RANGE 3 EAST, SALT LAKE BASE AND MERIDIAN, LOCATED IN PROVO, UTAH, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ALONG THE EDGE OF A ROAD LOCATED N00°53'07"W ALONG THE SECTION LINE 668.55 FEET AND EAST 1053.51 FEET FROM THE SOUTHWEST CORNER OF SECTION 7, TOWNSHIP 6 SOUTH, RANGE 3 EAST, SALT LAKE BASE AND MERIDIAN; THENCE N45°32'24"E 16.55 FEET; THENCE N13°49'04"E 10.52 FEET; THENCE N84°59'00"E 27.22 FEET; THENCE S26°35'33"W 22.70 FEET; THENCE S33°15'36"W 4.65 FEET; THENCE N90°00'00"W 28.72 FEET TO THE POINT OF BEGINNING.

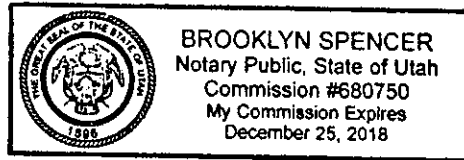
