EASEMENT

MYRTLE ANN HATCH RODGERS and DANIEL RODGERS, her husband, of Woods Cross, Davis County, State of Utah, Grantors, hereby transfer, convey and warrant to WASATCH OIL REFINING COMPANY, a Utah corporation, with its principal place of business in Davis County, State of Utah, Grantee, for the sum of One Hundred Dollars (\$100.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, an easement in, over and across the following described property situate in Davis County, State of Utah, to-wit:

Commencing at a point 3 chains West and 8.37 chains South of the Northeast corner of the Northwest Quarter of Section 25, Township 2 North, Range 1 West, Salt Lake Meridian; thence West 2.17 chains; thence South 6.73 chains; thence East 1.17 chains to the O. S. L. R. R. Co. right of way; thence northeasterly along said right of way 4.35 chains to the center of of the street; thence North along the center of the street 2.48 chains, more or less, to the point of commencement.

to impregnate the air with vapors, fumes, odors, smoke and gas and noises incident to the operation, maintenance, repair, renovation and cleaning out of the oil refinery of Grantee located upon the lands of Grantee hereinafter described wherein refined petroleum products are produced from crude petroleum oil, and hereby and by these presents waive perpetually for themselves, their heirs, executors, administrators, successors and assigns any and all damage which has arisen which does now arise or which may hereafter arise out of the operation, maintenance, repair, renovation, and cleaning out of said oil refinery of the Grantee, and all its operations incident thereto, and to additions thereto and extensions and expansions thereof, located upon the following described lands owned by the Grantee and all after-acquired

lands of Grantee, contiguous or adjacent to or in the vicinity of the above described land of the Grantors, which said lands of the Grantee are particularly described as follows:

A tract of land, the southernmost portion of which is described as follows:

Commencing at a point in the center of a 4 rod street running north and south 3.00 chains West and 3.939 chains South from the Northeast corner of the NW $\frac{1}{4}$ of Section 25, Township 2 North, Range 1 West, Salt Lake Meridian, and running thence South along the center line of said street 4.432 chains, more or less, to the intersection of the center line of said street with the center line of a rod east and west street; thence East 0.95 of a chain, more less, to the right of way of the O. S. L. R. R. Co.; thence Northeasterly along said right of way 4.676 chains, more or less, to a point due east of the point of beginning; thence west 2.22 chains, more or less, to said point of commencement.

and the northernmost portion of which is described as follows:

Commencing at the intersection of the North line of Joseph C. Wood's land with the easterly line of the spur of the O. S. L. R. R. Co. at a point 10.82 chains North and 1.22 chains East from the Southwest corner of the Southeast Quarter of Section 24, Township 2 North, Range 1 West, Salt Lake Meridian, running thence East 13 rods and 2 feet to the West line of said Railroad Company's main track; thence in a Southwesterly direction parallel with and 50 feet distant from the center line of said Railroad Company's main track 14 rods to said easterly line of spur above mentioned; thence along said easterly line of spur on a curve in a northwesterly direction to the point of commencement. Being a portion of the SE $\frac{1}{4}$ of said Section 24. Also a tract of land one rod wide commencing at the northwest corner of said Jos. C. Wood's land on the East line of a certain street running north and south at a point 3 chains west and 10.82 chains north from the said Southwest corner of the SE $\frac{1}{4}$ of SEC. 24, and running east 14 rods and 4 feet to the westerly line of the spur above mentioned, and situated within the limits of the SE $\frac{1}{4}$ and SE $\frac{1}{4}$ of said Section 24.

S. L. 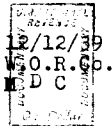

PARCEL 1:

Part of the S $\frac{1}{2}$ of the SE $\frac{1}{4}$ of Section 24, Township 2 North, Range 1 West, Salt Lake Meridian, described as follows: Beginning 19.20 chains West, 29.815 chains South from the Northeast corner of the SE $\frac{1}{4}$ of said Section 24, running thence West 15.53 chains to the easterly line of the right of way of the Oregon Short Line Railroad Company; thence North 19° 13' East along said right of way 6.64 chains; thence East 13.03 chains; thence South 6.30 chains to the point of beginning.
