WHEREAS, the purpose of LORA is to represent the social, aesthetic and financial interests of members, and to take action to pursue such interests, relating to members' ownership of and residence at homes in the Legacy Subdivision area of the South Mountain Development, which generally consists of eighty-one (81) building lots containing residences constructed by Pulte Corporation with detached garages, a number of over-the-garage living spaces, common areas, street areas and rights-of-way, all of which is more specifically identified on the attached map (the "Legacy Area").

WHEREAS, both South Mountain and LORA desire LORA to assume from the Board all rights and responsibility for the Design Review Process in the Legacy Area:

NOW THEREFORE; pursuant to Section 2.1.2 of the Design Guidelines, South Mountain hereby assigns to LORA all rights and responsibility for the Design Review Process under Section 2 of the Design Guidelines, including but not limited to rights and responsibilities for all submissions, documents, plans, approvals, amendments, appeals and other processes under Sections 2.1 through 2.8 of the Design Guidelines.


