IRON COUNTY, a body corporate and politic of the State of Utah, grantor, hereby conveys to  
O. C. SNOW

Richfield, County of Sevier, State of Utah,

for the sum of Five Thousand Seven Hundred Thirtythree and 44/100 - - - DOLLARS
