THIRD AMENDMENT TO CONDOMINIUM DECLARATION

FOR

ARCADIA GREEN TOWNHOMES

On April 4, 1995, the Condominium Declaration for Arcadia Green Townhomes (the "Declaration") was recorded with the Salt Lake County Recorder as Entry No. 6054325 in Book No. 7127 at Pages 2940 through 3008. On May 26, 1995, an Amendment to Condominium Declaration for Country Springs ("First Amendment") was recorded with the Salt Lake County Recorder as Entry No. 6088956 in Book 7158 at Pages 026 through 029. On March 7, 1996, a Second Amendment to the Declaration ("Second Amendment") was recorded with the Salt Lake County Recorder as Entry No. 6297924 in Book 7346 at Pages 1828 through 1856.

Pursuant to Section 16.02 of the Declaration and in accordance with Section 57-8-13.2 of the Utah Code Annotated, Declarant (Arcadia Green Townhomes, L.C.) hereby exercises its right to further amend the Declaration by adding Phase III to the Property of the Project. The legal description of Phase III which is hereby converted is identified in Exhibit A. Within the land comprising Phase III, twenty-two (22) additional Units shall be added as well as additional Common Area and Limited Common Areas as identified in the record survey map for Phase III which is being simultaneously recorded with this Third Amendment.

Pursuant to the Declaration, the additional twenty-two (22) Units, Common Areas and Limited Common Areas associated with Phase III shall be subject to all the provisions of the Declaration as if they were part of the original Property and Project. The new allocation of shared Common Expenses among the total forty-eight (48) Units within the total Project is set forth in Exhibit B attached hereto and made a part hereof.
