Also, beginning at the east boundary fence of the Grantors' land at a point 85 feet north and 33 feet west, more or less, from the east one quarter corner of Section 17, T. 10 S., R. 1 W., S.L.M., thence N.  $83^{\circ} 32'$  W. 2100 feet, more or less, to the west boundary line of said land and being in the S 1/2 of the NE 1/4 of said Section 17.

Also, beginning at the east boundary line of the Grantors' land at a point 535 feet north and 1330 feet east, more or less, from the west one quarter corner of Section 17, T. 10 S., R. 1 W., S.L.M., thence N.  $85^{\circ} 15'$  W. 1330 feet, more or less, to the west boundary line of said land and being in the SW 1/4 of the NW 1/4 of said Section 17.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
