POLE LINE EASEMENT

(UTAH CORPORATION)

LAZY S CATTLE COMPANY . . . . ., a corporation doing business in the State of Utah, Grantor, hereby conveys and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns and licensees, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution, and telephone circuits of the Grantee, and no guy anchors and 11 poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained on, under, upon and across the premises of the Grantor., in Utah County, Utah along a line described as follows:

Beginning at the east boundary line of the Grantors' land at a point 430 feet south and 1320 feet west, more or less, from the east one quarter corner of Section 16, T. 10 S., R. 1 W., S.L.M., thence N. 83° 32' W. 1360 feet, more or less, to the west boundary line of said land and being in the NW 1/4 of the SE 1/4 of said Section 16.

Also, beginning at the east boundary fence of the Grantors' land at a point 85 feet north and 33 feet west, more or less, from the east one quarter corner of Section 17, T. 10 S., R. 1 W., S.L.M., thence N. 83° 32' W. 2100 feet, more or less, to the west boundary line of said land and being in the S 1/2 of the NE 1/4 of said Section 17.

Also, beginning at the east boundary line of the Grantors' land at a point 535 feet north and 1330 feet east, more or less, from the west one quarter corner of Section 17, T. 10 S., R. 1 W., S.L.M., thence N. 85° 15' W. 1330 feet, more or less, to the west boundary line of said land and being in the SW 1/4 of the NW 1/4 of said Section 17.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
