
**SECOND AMENDED NOTICE OF REINVESTMENT FEE COVENANT
(Ivory Ridge)**

Pursuant to Utah Code § 57-1-46(6), the Ivory Ridge Master Property Owners Association, Inc. ("Association") hereby provides notice that a Reinvestment Fee Covenant ("Reinvestment Fee Covenant") burdens all of the real property described in Exhibit A ("Burdened Property"), attached hereto, which is subject to the "Second Amended and Restated Master Declaration of Covenants, Conditions, and Restrictions for Ivory Ridge", as recorded in the office of the Utah County Recorder on December 4, 2017 as Entry Number 119858:2017, and any amendments or supplements thereto ("Master Declaration").

The Master Declaration authorizes the Association to charge a reinvestment fee ("Reinvestment Fee Covenant"). The Reinvestment Fee Covenant shall be administered in accordance with Utah Code §57-1-46 and requires, among other things, that upon the transfer of any of the Burdened Property subject to the Master Declaration, the transferee is required to pay a reinvestment fee as established by the Association's Board of Directors, unless the transfer falls within an exclusion or exemption listed in either Utah Code §57-1-46(8) or in the Master Declaration. In no event shall the reinvestment fee exceed the maximum rate permitted by applicable law. However, Ivory Ridge is a "large master planned development" as defined under U.C.A. §57-1-46(1)(a). The reinvestment fee shall be paid in addition to any *pro rata* share of assessments due and adjusted at settlement.

This Notice may be expanded by the recording of supplemental notices to cover additional Units (defined in the Master Declaration) annexed into Ivory Ridge (if any). This Notice also replaces and supersedes any prior notices of reinvestment fees recorded against the Burdened Property.

BE IT KNOWN TO ALL OWNERS, SELLERS, BUYERS, AND TITLE COMPANIES owning, purchasing, or assisting with the closing of a Burdened Property conveyance within **IVORY RIDGE** that:

2. The burden and obligation of the Reinvestment Fee Covenant is intended to run with the Burdened Property and to bind successors in interest and assigns.
3. The duration of the Reinvestment Fee is perpetual, unless otherwise duly amended or terminated by the Association pursuant to applicable law.
4. The purpose of the Reinvestment Fee Covenant is to generate funds dedicated to benefitting the Burdened Property and payment for: (a) common planning, facilities, and infrastructure; (b) obligations arising from an environmental covenant (if any); (c) community programming; (d) open space; (e) resort facilities and recreation amenities; (f) charitable purposes; (g) Association reserves; (h) Association expenses (as defined in Utah Code § 57-1-46(1)(a); and/or (i) any other authorized use of such funds.
5. The fee required under the Reinvestment Fee Covenant is required to benefit the Burdened Property.
6. The amount of the Reinvestment Fee shall be established by the Association's Management Committee, subject to the applicable requirements of Utah Code §57-1-46 for a "large master-planned development". Unless otherwise determined by the Association's Management Committee the amount of the Reinvestment Fee shall be as follows:
 - One half of one percent (0.5%) of the value of an attached single-family dwelling Unit, including, specifically, but without limitation, any Unit within:
 - Clubview Towns at Ivory Ridge, Plats A and B
 - The Lofts at Ivory Ridge Condominium
 - The Walk at Ivory Ridge, Plats A, B, and C
 - Ivory Ridge Plat C
 - One quarter of one percent (0.25%) of the value of a detached single-family dwelling Unit within:
 - Clubview at Ivory Ridge Plats A, B, and C
 - Park Estates at Ivory Ridge, Plats A through G
 - Park Place Villas at Ivory Ridge Phases 1 and 2
 - Parkside at Ivory Ridge, Plats A through E
 - Parkview Cottages PUD, Plat
 - The Gardens at Ivory Ridge, Plats A and B
 - One quarter of one percent (0.25%) of the value of a commercial Unit.
7. As per the Master Declaration, for the purpose of this Notice, the "value" of the Unit shall be the higher of: (1) the value of the Unit, including any dwelling and other improvements that constructed thereon, as determined by the property tax assessor on the date of the transfer of title; (2) the purchase price paid for the Unit, including any dwelling and other improvements thereon; or (3) the value of the Unit, including

any dwelling and other improvements thereon, on the date of the transfer of title, as determined in an appraisal that may be obtained (in the discretion of the Management Committee) and paid for by the Association using an appraiser selected by the transferee of the property from a list of five appraisers selected by the Association.

8. The existence of this Reinvestment Fee Covenant precludes the imposition of any additional Reinvestment Fee Covenant on the Burdened Property.
9. As per the Master Declaration, the Management Committee may change the amount of the reinvestment fee via its rules. Therefore, you must contact the Association for the exact amount of the reinvestment fee for a particular Unit.


