Monson Acting Governor, in consideration of the premises, and by virtue of the power and authority vested in my by the laws of the State of Utah, in such case made and provided, do issue this PATENT, in the name and by the authority of the State of Utah, hereby granting and confirming unto the said George A. Berry and to his heirs and assigns forever, the following piece or parcel of land, situate in the County of Iron State Aforesaid, to-wit: Lots One (1), Two (2), Three (3), Four (4), Five (5), Six (6), and Seven (7), Southeast Quarter (SE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Thirty-two (32), in Township Thirty-seven (37) South, Range Twelve (12) West of the Salt Lake Meridian, (Reserving to the State of Utah, all coal and other minerals in the above lands, and to it, or persons authorized by it, the right to prospect for, mine and remove coal and other minerals from the same, upon compliance with the conditions and subject to the limitations of Title 86-Chapter 1, Revised Statutes of Utah 1933 and amendments thereto.) containing Three Hundred Thirty and 50/100 (330.50) acres according to the said certificate.
