ORDINANCE #99-24


AN ORDINANCE ADDING THE NAME OF MONROE PLAZA WAY TO  
THE STREET CURRENTLY KNOWN AS 150 WEST, AFFECTING  
PROPERTIES SOUTH OF 9107 SOUTH.

BE IT KNOWN AND REMEMBERED that the City Council of Sandy City, State of  
Utah, finds and determines as follows:

1. The Sandy City staff has requested that the name of Monroe Plaza Way be added to  
the street currently known as 150 West, affecting properties south of 9107 South; and
2. A public hearing was held on June 22, 1999 with regard to the proposed name  
addition, notice of which was posted in Sandy City Hall, Sandy Parks & Recreation, Salt Lake  
Community College and Sandy Library on May 24, 1999 and published in the Tribune on May  
24, May 31, June 7 and June 14, 1999.
3. The Sandy City Council is satisfied that there is good cause for such change of street  
name and that such change will not be detrimental to the general interest and that such name  
change should be made as shown in Exhibit A attached hereto.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Sandy City, State of  
Utah, that the name of Monroe Plaza Way be added to the street currently known as 150 West,  
affecting properties south of 9107 South, upon publication of a summary of this ordinance.
