This Amendment is made as of the 1<sup>st</sup> day of August, 1999, amending that certain Declaration of Covenants, Conditions, Restrictions and Easements Pertaining to a Portion of the Surface of Block 57, Salt Lake City, Utah, as recorded July 3, 1995 in the records of the Salt Lake County Recorder, Entry No. 6113370 and amended by a First Amendment thereof dated December 20, 1996, as recorded in the records of the Salt Lake County Recorder, Entry No. 6551315 in Book 7579 at Page 1911.
