5. Grantee hereby agrees to indemnify and hold harmless Grantor and its successors and assigns from any and all claims costs, suits, actions at law and/or damages of any kind arising from Grantee's and the public's use of the Easement Parcel.

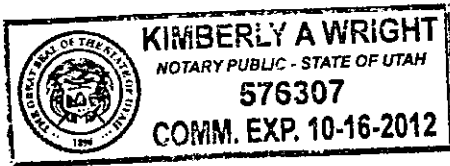

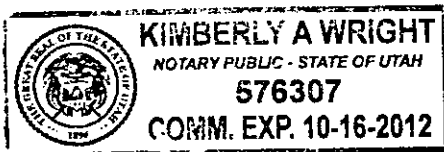

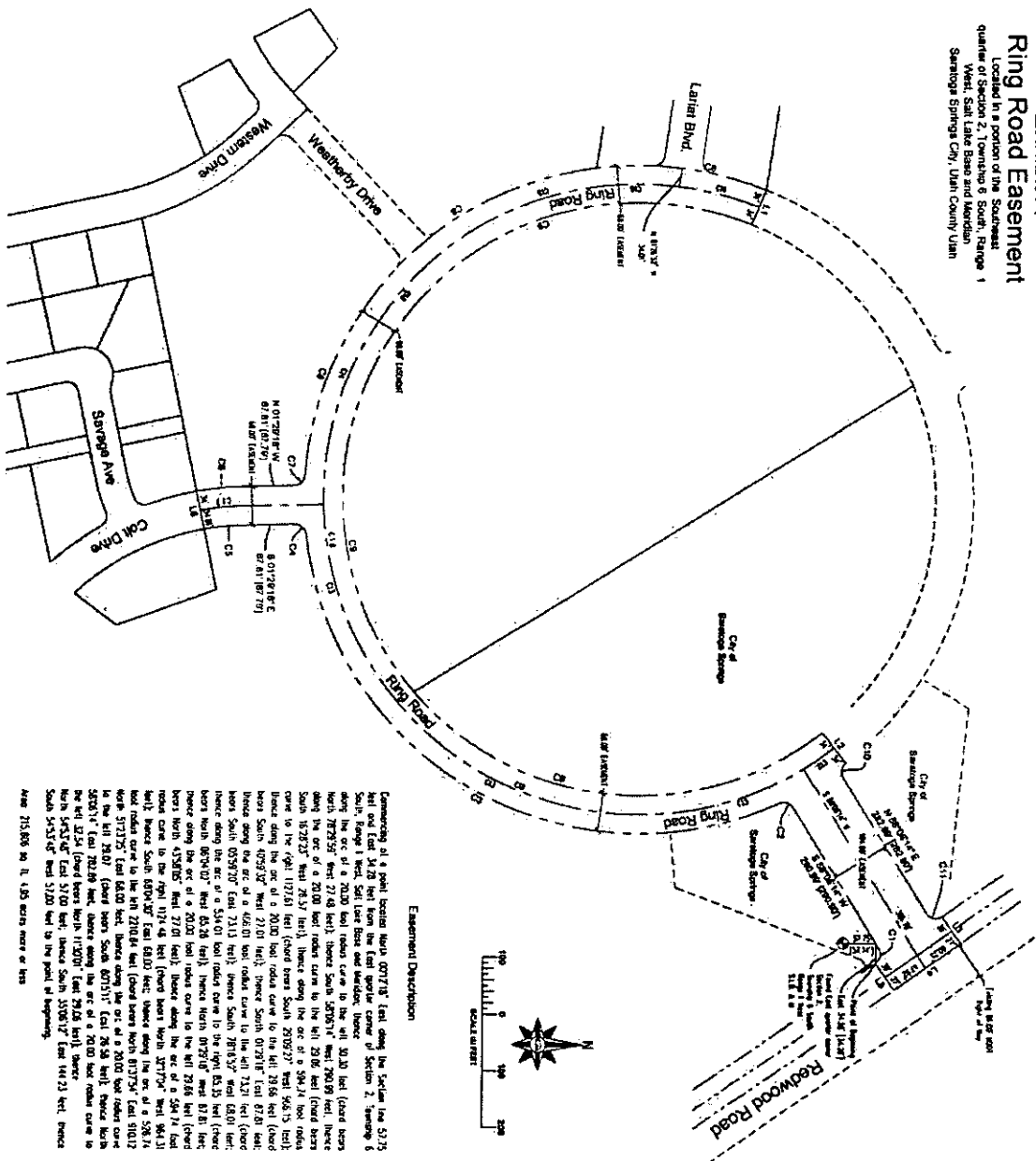
