RIGHT-OF-WAY EASEMENT

Eaglebrook Corporation, a Utah corporation, and R.C. Tolman and Arleen Ann Tolman, as Trustees of the R.C. Tolman and Arleen Tolman Revocable Family Trust under agreement dated June 19, 1996 (collectively "Grantor"), for Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, hereby grants, bargains, sells and conveys to Ledges Land, LC, a Utah limited liability company, and its successors and assigns, ("Grantee"), a perpetual right-of-way easement for (1) ingress and egress of vehicular and pedestrian traffic; and (2) the construction, reconstruction, operation, maintenance, repair, replacement, and removal of water, electrical, gas, telephone, cable television, communications and other utility lines and all necessary or desirable accessories and appurtenances thereto, including, without limitation, supporting manholes, poles, vaults, guys and cabinets. The easement is on, over, under, above and across a strip of land located in Washington County, Utah, and described on Exhibit A, which is attached hereto and incorporated herein.

Grantor agrees, upon request of Grantee, to execute a replacement Right-of-Way Easement in favor of Grantee that will change the location of the easement in order to more directly access the well on BLM property to the east of Grantor's property. Upon recording of the replacement Right-of-Way Easement, Grantee shall release this Easement.

Grantee shall have a reasonable right of access to the easement from adjacent lands of Grantor for all activities in connection with the purposes for which this easement has been granted; and together with the present and (without payment therefor) the future right to keep the easement clear of all brush, trees, structures, rocks and other hazards or obstructions which might endanger Grantee's facilities or impede Grantee's activities on, or use of, the easement.
