## Legal Description

A part of the Southwest Quarter of Section 17, Township 13 North, Range 1 West of the Salt Lake Base and Meridian described as follows:

Commencing at the Northwest corner of Block 19, Plat "A" of the Newton City Survey and running thence South 01°53'23" West along the East right of way line of Center Street in Newton City, Utah 239.57 feet to the true point of beginning; thence leaving said East right of way line and running South 88°06'37" East 163.52 feet; thence South 01°53'23" West 77.48 feet; thence South 88°06'37" East 182.24 feet to a point on an existing held fence line; thence following said fence line the following two courses: South 00°34'09" West 17.37 feet; thence South 03°02'51" West 87.79 feet; thence leaving said fence line North 88°03'05" West 344.38 feet (330.00 feet by record) to a point on the aforesaid East right of way line; thence following said right of way line North 01°53'23" East 182.26 feet to the point of beginning.

Together with an access easement described as follows: Commencing at the Northwest Corner of aforesaid Block 19 and running thence South 01°53'23" West 239.57 feet to the true point of beginning and thence running South 88°06'37" East along the North property line parcel #13-023-0008 163.52 feet; thence leaving said property line North 01°53'23" East 14.17 feet; thence North 88°06'37" West 50.34 feet to the Northeasterly corner of an asphalt driveway; thence following the North edge of said asphalt driveway the following two courses: North 81°22'40" West 78.64 feet; thence North 83°03'27" West 35.22 feet to a point on the aforesaid East right of way line; thence leaving said North asphalt driveway edge and following said East right of way line South 01°53'23" West 26.49 feet to the point of beginning.
