AMENDMENT NO. ONE TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF BATEMAN FARMS PLANNED UNIT DEVELOPMENT

AMENDMENT

The Declaration of Covenants Conditions and Restrictions of Bateman Farms Planned Unit Development referenced above is hereby amended to modify the contents of Article VII USE RESTRICTIONS, at Sections 7.3(d) and 7.5 which, as amended, shall read as set forth below. This Amendment shall supersede and replace any inconsistent provisions of the Declaration of Covenants Conditions and Restrictions of Bateman Farms Planned Unit Development.

Subsection (d) of section 7.3 entitled "Building Features and Materials" shall appear as follows:

(d) <u>Fences and Walls.</u> Subject to the exceptions set forth below and except as to fences installed by Declarant, fencing shall be installed by each Lot Owner on rear and side yards and shall be constructed of wrought iron, wood or vinyl in accordance with the guidelines established by the Architectural Control Committee.

Fences shall not extend past the front of any Living Unit. On corner Lots, the fence on the side Lot line adjacent to the street shall not be closer than 5 feet to that side Lot line.

Section 7.5 entitled "Recreational and Other Large Vehicles" shall appear as follows:

7.5. Recreational and Other Large Vehicles. Unless stored in a fenced yard or an enclosed garage, no boats, trailers, large trucks and commercial vehicles belonging to Owners, their guests and invitees, or other residents of the Property shall be parked within the Development, except temporary parking not to exceed forty-eight (48) hours. No motor vehicles of any kind shall be repaired within the Development; provided, however, that such restrictions shall not apply to emergency repairs to vehicles. Any motor or recreational vehicle must be kept in an enclosed garage or fenced yard.

This Amendment to the Declaration of Covenants Conditions and Restrictions of Bateman Farms Planned Unit Development, shall take effect upon recording in the office of the County Recorder of Salt Lake County, Utah by McCARTHUR HOMES AT BATEMAN FARMS, LC.

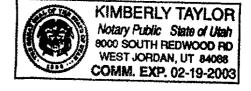
